MATERNAL AND NEWBORN NUTRITION PROGRAM

Project Overview:

Shifa Foundation is implementing the MNHN program in five program districts spanning four provinces of Pakistan. These include Sindh (Jamshoro and Khairpur), Punjab (Lodhran), Khyber Pakhtunkhwa (Swabi), and Baluchistan (Ziarat).

Program Achievements:

During the reporting quarter, the program team has put in relentless effort to achieve the specified targets, as outlined below:

1. Stakeholder Meetings:

Meetings at both the national and provincial levels have played a pivotal role in the five program districts' journeys toward progress and implementation. These gatherings serve as a dynamic platform to showcase the remarkable strides made within the program, highlighting its tangible impact. Moreover, they provide a valuable opportunity to engage stakeholders, garner their support, and foster collaboration. Through open dialogue and shared insights, these meetings not only celebrate achievements but also chart a collective path forward, ensuring the continued success and growth of the program in these vital districts.

2. Enhancing Healthcare Services:

In pursuit of enhancing healthcare services, our initiative focuses on providing essential technical support to district health departments. This support encompasses the strengthening of supply chain systems,

including infrastructure, IT, and reporting tools. Our efforts span across multiple regions, each with its unique challenges and requirements, as outlined below:

- In Sindh, collaborative meetings with key stakeholders in the District Health Offices of Jamshoro and Khairpur have facilitated a comprehensive assessment of existing supply chain processes.
- In Punjab, Lodhran, NI has supplied a UPS and battery to the MIS section, reaffirming our commitment to provide strong support.
- In Khyber Pakhtunkhwa, District Swabi, meetings with key stakeholders have been instrumental in addressing infrastructure needs, particularly the renovation of a meeting hall in the new District Health Office building.

3. Advocacy for Kangaroo Mother Care (KMC):

NI's advocacy efforts have been instrumental in advocating for the scale-up of Kangaroo Mother Care (KMC) services and the integration of KMC-related indicators into the District Health Information System II (DHIS II) across multiple provinces.

4. Operational Plans for KMC Services:

Advocacy meetings have been instrumental at both the national and provincial levels, aiming to develop an operational plan for the scaling up and expansion of Kangaroo Mother Care (KMC) services in Sindh and Punjab.

5. KMC Training and Support:

In an extensive effort to enhance Kangaroo Mother Care (KMC) practices across four provinces, significant strides have been made. These include refresher training sessions and orientations in various districts to promote effective KMC implementation.

6. Establishing KMC Wards:

In the pursuit of advancing maternal and child health in Ziarat district, the MNHN program has taken crucial steps towards establishing a Kangaroo Mother Care (KMC) Ward.

7. Monitoring and Evaluation:

Monitoring visits by the MNHN program's NI team to KMC wards in Sindh have been instrumental in providing essential technical support to healthcare staff and facilitating the collection of monthly reports. Similar efforts have been made in Punjab and Khyber Pakhtunkhwa.

8. Community Awareness Sessions:

A series of community awareness sessions and seminars were conducted to educate and inform target groups on crucial health and nutrition matters.

9. The program team demonstrated remarkable efficiency in coordinating World Breastfeeding Week (WBFW) activities across the five program districts. Their efforts were characterized by seamless collaboration with the Department of Health, overseen by the District Health Officers of both regions. In partnership with Nutrition International, they meticulously devised a comprehensive plan to promote optimal breastfeeding practices through essential messaging, which was then effectively carried out in community-level engagements. These



activities included awareness sessions for pregnant and lactating women, seminars led by LHSs and LHWs, orientation sessions for healthcare providers and frontline workers, awareness sessions for husbands and male community members, an informative radio program featuring interviews with doctors and public health experts, advocacy through IEC materials and banners at public places and transportation hubs, the dissemination of messages through religious scholars during Juma-Namaz prayer khutba, publication of articles, media coverage, and interactive discussions with BNP at Ziarat.



FOOD SECURITY, LIVELIHOODS SUPPORT, AND ACCESS TO NUTRITION SERVICES IN THE FLOOD-AFFECTED DISTRICT MATIARI SINDH

Overview:

Shifa Foundation, in collaboration with Care International, is actively engaged in a comprehensive initiative titled "Food Security, Livelihoods Support, and Access to Nutrition Services in the Flood-Affected District Mitiari Sindh." This project has a primary goal of providing substantial assistance to families by offering direct financial aid, enhancing agricultural and livestock-based livelihoods, and promoting initiatives related to kitchen gardening. Our project aims to tackle challenges such as household food expenses, alleviating debt burdens, and boosting agricultural and livestock productivity.

Moreover, project places a strong emphasis on addressing nutritional issues within the community. This includes evaluating the nutritional well-being of children under the age of five and pregnant and lactating women. The approach encompasses -- the treatment of Severe and Acute Malnutrition (SAM) in children, prevention, and



management of micronutrient deficiencies in children and women through the distribution of Multiple Micronutrient Powder (MNP), advocating for appropriate feeding practices among infants and young children, and undertaking capacity-building efforts.

Overall Progress:

Staff Training and Capacity Building: Shifa Foundation, in collaboration with Care International and Australian Aid, successfully organized a three-day staff orientation training. The training covered a wide array of topics, including Nutrition, Food Security, Livelihood, Gender-Based Violence (GBV),

Disaster Risk Reduction (DRR), and Menstrual Hygiene Management (MHM). The staff training and capacity-building sessions equipped the project team with essential knowledge and skills in nutrition, food security, livelihood, and other critical areas. This knowledge to be transferred to the community through awareness campaigns and training programs.



Formation of Village Committees: Village committees have been established in 30 villages across eight union councils. These committees are intended to assist our team in various tasks such as assessment, screening, and service provision. These committees helped identify community needs, facilitate communication, and ensured that services reach those in need effectively.



Village Profiling: Profiles for a total of 71 villages within the targeted eight union councils have been completed by the team.

Livelihood Cash Grant & Kitchen Gardening Assessment: A comprehensive assessment was conducted for livelihood cash grants (718 assessments) and kitchen gardening (1,429 assessments) in the eight targeted union councils of Matiari district. The assessments for livelihood cash grants and kitchen gardening helped identify beneficiaries who can improve their livelihoods. This support can lead to increased income and food security among community members.

Validation of Cash Grant & Kitchen Gardening: District Coordinator, Meal Officer, and Cash Grant Officer successfully validated 1,396 beneficiaries in 8 union councils. Among these, 439 beneficiaries were recommended for livelihood cash grants, 761 beneficiaries were recommended for kitchen gardening, while 79 beneficiaries were not recommended for livelihood cash grants, and 117 beneficiaries were not recommended for kitchen gardening.



CARE International Team Visits:



- CARE International team visited Shifa Foundation office in Matiari, holding meetings to discuss ongoing project activities, progress, and planning. The team also engaged with the community and monitored field activities.
- Another team from CARE visited Shifa Foundation office in Matiari, Hala, where they conducted meetings with the District Coordinator to discuss ongoing project activities and progress. They also visited the field to engage with the community and monitor project activities in Village Abdul Wahid Buriro in UC Zair Peer.
- In Village Ghulam Shah Mari in UC Nobat Mari, Ms. Paras from CARE visited the field to

engage with the community regarding project activities and monitored Shifa Foundation's team during field activities.

World Breastfeeding Week Celebration: Shifa Foundation District Mitiari team celebrated "World Breastfeeding Week 2023" with enthusiasm. They conducted awareness sessions in 8 union councils under the theme "Enabling breastfeeding: making a difference for working parents." Additionally, an awareness walk was organized in two villages, and an awareness seminar took place at Law College, Hala.



Participation in Independence Day Event: District Coordinator of

Shifa Foundation Mitiari played a key role in an event commemorating Independence Day on August 14, 2023, at the Deputy Commissioner Office Mitiari. Various government officials participated and discussed the history of August 14, 1947.

Visit of Manager WASH & DRR/Project Manager: Mr. Zaheer Malik (Manager WASH & DRR Shifa Foundation), visited Shifa Foundation office in Matiari. He conducted a meeting with the staff to discuss progress and planning, visited the NSC at Taulka Hospital Hala, and monitored ongoing activities in field areas.

Strengthening of Nutrition Stabilization Center (NSC): Shifa Foundation, with support of CARE and Australian Aid, strengthened the Nutrition Stabilization Center at the Taluka Headquarters Hospital Hala. This included various improvements and essential items, and the work was completed by a vendor. The effort was appreciated by district health officials and stakeholders.

FLOOD EMERGENCY AND RESTORATION OF WASH (WATER, SANITATION AND HYGIENE) FACILITIES OF THE AFFECTED POPULATION IN SINDH

Brief:



The year 2022 witnessed one of the worst monsoons in the recorded history Sindh, resulting in a catastrophic flood that had a profound impact on both the people and the region's infrastructure. This disaster left behind a of destruction, trail affecting homes, public healthcare facilities,

water supply systems, and educational institutions. The consequences have been dire, particularly regarding access to clean water, sanitation, and hygiene (WASH) services. In the aftermath of this disaster, open defecation rates in the flood-affected areas surged by more than 20%, posing a significant public health risk.



Contamination of water sources further compounded the crisis, leaving communities without access to safe and clean drinking water. Stagnant water in several villages has led to the outbreak of water-borne diseases, intensifying the suffering of the population.

Recognizing the urgent need to address these dire circumstances, Shifa Foundation, in collaboration with UNICEF, initiated a vital project titled "Emergency Relief and Restoration of WASH Facilities for the Affected Population in Umerkot and Sanghar Districts of Sindh." Our primary objective is to address pressing challenges and the core mission of this project is to enhance WASH facilities, leading to a substantial improvement in the overall well-being and quality of life for more than 200,000 individuals residing in approximately 30,000 households. Through our commitment to sustainable solutions, we aim to ensure access to safe water, sanitation, and hygiene. By doing so, we aspired to bring about a wave of positive change for the communities affected by these challenges. Our project endeavors to restore hope, health, and dignity to the lives of those affected by the disaster, ensure access to clean water, improved sanitation facilities, and enhanced hygiene practices.

Overall Progress:

 Ultra-Filtration Plant Handover (August): A significant event on August 18, 2023, marked the handover of Ultra Filtration Plants to government schools and hospitals by Shifa Foundation. This gesture further enhanced access to clean water for these institutions.



2. Community Engagement and Literacy (September):

Shifa Foundation-WASH Umerkot team actively participated in events to promote education and literacy. This included attending a seminar on **International World Literacy Day** organized by Sami Foundation in collaboration with ACTED, showcasing Shifa Foundation's commitment to community development.

- UNICEF Field Visits: UNICEF representatives
 Miss Zahida Jamali (WASH Coordinator) and
 Engr. Murtaza (WASH Consultant) conducted
 field visits to Shifa Foundation's intervention
 areas, ensuring the quality and effectiveness
 of our projects.
- 4. UNICEF Karachi Team Visit: Representatives from UNICEF Karachi regularly visited our offices and project sites, emphasizing the importance of financial and logistical procedures and product quality.
- 5. UNICEF WASH Consultant Visit: Engineer Murtaza, WASH Consultant, conducted a site visit to assess Shifa Foundation's water supply scheme. The visit aimed to evaluate project progress, effectiveness, and sustainability. Activities during the visit included site inspections, community engagement, technical evaluation, data collection, meetings with stakeholders, and an assessment of sustainability. The visit likely provided valuable insights and recommendations to ensure the project's success and benefit to the local communities, a common practice in the field of WASH and development work.



6. Behaviors Changed Community (BCC) Training for Staff: Miss Sajida & Mr. Murtaza from

UNICEF conducted one-day training for the staff on Behaviors Changed Community, for promoting positive changes in behavior, encompassing various aspects of life such as health, personal development, addiction recovery, sustainability, and more. All participants gained a deeper understanding of the issues related to nutrition, GBV, PSEA, WASH, and Child Protection, health & education including their significance, challenges, and best practices. Main



purpose of the training was to contribute to a safer and more equitable environment for individuals and communities, addressing the specific challenges associated with gender-based violence, financial accountability, sanitation, education, and child protection.

INTEGRATED FLOOD RESPONSE-BALUCHISTAN

Shifa Foundation is presently executing the IFR Integrated Flood Response Project in select districts of Baluchistan Province in partnership with UNICEF. As of now, the project is fully operational in four districts: **Jaffarabad, Naseerabad, Sohbat Pur**, and **Quetta.** In this reporting quarter, the IFR Project's operational activities commenced in Quetta District, and the Provincial Team initiated the hiring process in Dera Bugti District. The upcoming reporting period will mark the start of project

implementation, particularly the screening and identification activities, in Dera Bugti as well.

In this reporting period, the IFR Project is engaging in a range of significant activities, with a primary focus on conducting household-level assessments and screenings. These screenings are based on measuring Mid Upper Arm Circumference (MUAC) and target children aged 6 to 59 months. The assessments are carried out by regional district teams from Shifa Foundation. In cases where children are identified as Severely Acute Malnourished (SAM), they are swiftly referred to Outreach Therapeutic Centers (OTPs) managed by various organizations, including the Nutrition Directorate, UNICEF, PPHI, and the Government Health Department. At these centers, children receive crucial support in the form of Ready to Use Therapeutic Food Supplements (RUTF) and other essential services.

Shifa Foundation team is actively engaged in providing counseling and sensitization sessions to the project beneficiaries including but not limited to pregnant & and lactating women, adolescent girls, and others. These sessions cover a wide range of topics, including nutrition, the importance of clean water and proper sanitation, health


and hygiene best practices, and guidelines for healthcare. These educational initiatives are not only crucial for the growth and well-being of children but also for mothers, as they play a vital role in nurturing the health of society.

Overall Progress & Project Updates

This table provides total summary of screening of three Districts Jaffarabad, Naseerabad, SohbatPur & Quetta highlighting the total number of children identified as SAM and MAM across all categories of age indicator i.e. (6 to 59 months).

- number of children screened across all categories is 35536.
- Total number of children identified as severely malnourished (SAM) across all categories is 1863.
- The total number of children identified as moderately

malnourished (MAM) across all categories are 6594.



This summarizes the screening results for different age groups and genders, helping track the prevalence of malnutrition among children in the given population of 04 Districts i.e., Jaffarabad, Naseerabad, SohbatPur & Quetta).

IFR Screening of PLW's & Identification of Malnourish

Under IFR project Field Teams also conducted screening of Pregnant & lactating women's & identified malnourish cases This graphical presentation provides a summary of the total screening and the total number of pregnant and lactating women identified as malnourished across different categories of age which is less than 18 and more than 18 years of age

- The total number of pregnant and lactating women screened across different age group is 7976.
- The total number of pregnant and lactating women identified as malnourished across all categories is 1099

This table summarizes the screening results for pregnant and lactating women, categorizing them by age groups and pregnancy/lactation status. It helps track the prevalence of malnutrition among these women in the given population of 03 Districts namely Jaffarabad, Naseerabad, SohbatPur & Quetta.



Nutrition Commodities/ Supplies Distribution

There are five different commodities which were distributed these five commodities included;

- RUTF (Ready to use Therapeutic Food): It is a specialized food product used to treat severe acute malnutrition, especially in children. Total of 146012 units of RUTF were distributed. That number cover almost 37% of total distribution of commodities.

- MMS (Multi Micronutrient Supplements) These are supplements that provide a combination of essential vitamins and minerals. A total of 11,798



units of MMS were distributed during the reporting period which is equal to 3% of the total distribution.



- MMTs (Multi Micronutrient Vitamins) Total of 214089 units were distributed. Overall MMT share is 54% of total distribution.

- IFA (Iron and Folic Acid Supplements/ tab)

These supplements are provided to pregnant & and lactating women & and adolescent girls to prevent iron deficiency anemia. A total of 22301 units or doses of Iron and Folic Acid supplements/ tab were distributed which is equal to 06 % of overall distribution.



HEALTH, NUTRITION & CP INTEGRATED FLOOD RESPONSE – SINDH

Project Overview:

Shifa Foundation, in partnership with UNICEF, has been diligently executing "The Integrated Flood Response Project" in flood-affected districts, namely Umerkot, Mirpur Khas, Sanghar, Naushahro Feroze, Khairpur, and Shaheed Benazir Abad. The project is a holistic response, offering crucial Health, Nutrition, and Child Protection services to the affected populations in these regions.

Quarterly Highlights (July to Sep):

NUTRITION COMPONENT

- Over the three-month period, a total of 359,340 children under the age of five received Nutrition screenings, ensuring their well-being was prioritized.
- A total of 18,097 children diagnosed with Severe Acute Malnutrition (SAM) were identified and admitted for appropriate treatment and care.
- 134 children in critical condition were referred to the Nutrition Stabilization Center (NSC) for comprehensive assistance and support.
- A significant achievement was reaching and providing essential Mic ronutrient Powder (MNP) to 33,190 children aged 6-59 months, contributing to their nutritional well-being.
- Deworming treatment was administered to 81,924 children, effectively protecting them from parasitic infections.
- Pregnant and Lactating Women (PLWs) were not overlooked, as 140,536 of them were screened for health, ensuring their well-being during this critical period.
- Out of these PLWs, 36,258 were identified and 34,751 received Iron and Folic Acid (IFA) supplements to improve their nutritional status.
- Additionally, 38,818 PLWs were administered deworming treatment, safeguarding both them and their infants from parasitic infections.





HEALTH COMPONENT

In the context of the Integrated Flood Response in Sindh's Health Component, a comprehensive set of activities was undertaken to address the health needs of the affected population. These efforts resulted in notable achievements, with a total of 105,628 Primary Healthcare Centers (PHCs) being established to essential medical provide services. Additionally, 9,658 children received routine vaccinations, ensuring their protection against preventable diseases. The program also focused on maternal health, with 26,465 cases of Antenatal Care (ANC) services and 6,128 cases of Postnatal Care (PNC) being provided. For



obstetric care, 1,478 referrals for delivery were made, and 1,439 deliveries were successfully assisted at healthcare facilities.

• In addition to maternal and child health, the program distributed 1,099 Clean Delivery Kits (CDKs) and 949 Newborn Kits, further enhancing safe childbirth practices. Disease management was a crucial aspect of the respon se, with thousands of cases being addressed: 8,483 cases of diarrhea, 926 cases of dysentery, 11,458 cases of Acute Respiratory Infections (A.R.I) and Pneumonia, 2,404 cases of malaria, 20 cases of dengue, 2,015 instances of deworming, 7,510 cases of skin disorders, and 13,615 cases of other diseases.



CHILD PROTECTION COMPONENT

Overall Progress:

Recruitment of Staff: As per the project plan, the recruitment of 05 Social Organizers and 05 Child Protection Facilitators was initiated for the third phase of the Child Protection (CP) component in



District Sanghar. Following a comprehensive evaluation, 04 male and 03 female staff members were retained due to their outstanding performance. Additionally, 01 male Social Organizer and 02 female Child Protection Facilitators were successfully hired from a pool of 10 candidates who underwent interviews conducted by a panel consisting of HR, Administration, and District Coordinator at Shifa Foundation CP office in Sanghar. A qualified and gender-balanced team of Child Protection staff members has been established, contributing to the project's effectiveness.

Orientation Session of CP Staff: A two-day orientation session was conducted for the newly recruited and retained staff. The primary objective of this session was to familiarize the staff with the CP project's objectives and strategies, enabling them to commence their mobilization activities adequately. Various components, such as GBV, MHPSS, PSS, and Safe Space strategy, were discussed using IEC materials. Coordination meetings, Interactive Theatre, relocation of Safe Spaces based on assessments, and reporting processes were also covered.



Staff members are well-informed about the project's objectives, strategies, and various components, ensuring effective project implementation.

Revisiting Static Safe Spaces: In line with the project's integrated approach, a reassessment of existing Safe Spaces and Mobile Safe Spaces was conducted. District Coordinator CP, along with the staff, visited all static Safe Spaces and, after community meetings and consultations with elders, decided to relocate the Safe Space from Iqbal Ahmed Burdi to the nearby Ali Bux Shah village. The decision was made due to a lack of community ownership and support for project activities in the previous location which has led to improved



community engagement and ownership by relocating the Safe Space to a more supportive environment.

Three Days Behavior Change Communication Training: A three-day training on Behavior Change Communication was organized from September 26th to 28th, 2023, in collaboration with UNICEF,



Social Welfare Department, and Oxford Policy Management (OPM) at the Indus Hotel in Hyderabad. Participants included all UNICEF Hyderabad Hub Implementing Partners, such as IRC International, Indus Resource Centre, DevCon, and Shifa Foundation. The training focused on sharing experiences, lessons learned, field practices, behavioral issues in the community and society, and strategies to address them through group discussions and presentations. Major outcome was the enhanced knowledge and capacity among implementing partners for effective Behavior Change Communication strategies, contributing to better

community engagement and behavior change in project areas.

Interactive Theatres: Interactive Theatre has been a powerful Behavior Change Communication tool

at the community level. Local youth, trained by Shifa Foundation, organized theater events in Iqbal Burdi and Jabbar Mari villages, Tehsil Sanghar. These plays addressed Child Protection Risks, including early marriage, sexual abuse, violence, and neglect, encouraging the audience to report incidents to **1121** if witnessed. Now there is increased community awareness and understanding of Child Protection Risks through engaging theater performances.



FM Radio Station: CP messages were developed and broadcasted through FM Radio, reaching the corners of District Sanghar and surrounding areas. Radio served as an effective medium for disseminating sticky CP messages that resonated with diverse audiences. Wide-reaching awareness of Child Protection issues through FM Radio broadcasts.

Training of Teachers, Police, SWD, Women Development Department, and CP Staff: A two-day training workshop organized by Shifa Foundation covered Teachers, Police officials, and Social Welfare Department staff in Sanghar. The training, attended by 50 participants, focused on Protection from Sexual Exploitation, Abuse (PSEA), Child Protection, and Gender-Based Violence (GBV). Main goal was to enhance awareness among stakeholders about the impact of CP issues on child development and survival, promoting proactive engagement and support.

BISP KAFALAT

Project Overview:

Given the child nutrition crisis and the significance of early childhood development, Shifa Foundation is collaborating with the World Food Programme (WFP) to execute a program that supports the Nashonuma Program and the Ehsas Kafalat Program in Sukkur, Hyderabad, and Karachi regions. This initiative also aims to enhance the RMNCH programs, particularly by providing vehicles for monitoring project interventions. Together, this partnership seeks to tackle the root causes of malnutrition, enhance maternal and child health, and alleviate poverty within vulnerable communities. Provision of monitoring support to the RMNCH department, establishing facilitation centers, and deploying

mobilization teams to create awareness, educate the BNP beneficiaries, and identify and assist the target beneficiaries, Shifa Foundation aims to enhance the reach and impact of the programs.

The objective is to improve the healthcare services, socio-economic conditions, and overall well-being of the

target population. Through strategic interventions and a robust methodology, we aspire to make a significant difference in reducing malnutrition and ensuring a



brighter future for the children and families in these regions.

Highlights of Quarter:

Over the course of three months, from July to September 2023, Shifa Foundation, in collaboration with WFP, made substantial progress in the BNP- PBW & Children Registration Program across 16 districts with 25 teams. Notably, new enrollments during this period included 2,092 pregnant and



lactating women as well as 2,447 children. Additionally, follow-up care was extended to 34 pregnant and lactating women and 56 children, ensuring their continued well-being. Furthermore, the project achieved the discharge and recovery of 3 pregnant and lactating women and 3 children. Health services delivered during these three months were robust, with 2,092 women receiving counseling on breastfeeding during antenatal care, and the same number receiving

nutrition counseling. Although no cooking demonstrations were conducted, an impressive 2,092 women were provided with other health-related counseling, and 355 children received various forms of health-related support. This collective achievement over the three-month period underlines the project's dedication to improving the health and well-being of vulnerable populations in these 16 districts.

In the reporting period, the BISP Kafalat Programme in Sindh achieved several significant milestones. The project was initiated by conducting two crucial planning meetings with the World Food Programme (WFP), setting the foundation for successful collaboration. Staff hiring was successfully completed, ensuring the project's operational capacity. Coordination meetings with the IRMNCH departments were held to enhance the project's effectiveness.

A two-day staff training program was conducted, including two separate events in Hyderabad and Karachi, equipping the project teams with the necessary knowledge and skills. The project garnered essential support from the Directorate General of Health (RMNCH department) and obtained letters of reference and endorsement for all relevant District Health Officers (DHOs) and Deputy DHOs (DDHOs) within RMNCH.

This progress continued as letters from RMNCH to the BISP district head were received, covering all districts in Sindh, and reinforcing the project's scope. Additionally, coordination meetings were successfully held with DHOs and DDHOs within RMNCH, expanding the project's reach.

Critical tools, including anthropometric instruments and tablets, were acquired from WFP and handed over to the project team, extending from Kashmore to Karachi. Warehouses were rented in Karachi, Tharparkar, and Sanghar, providing the necessary infrastructure for the program's operations.

The project also achieved a significant milestone by finalizing the printing of Management Information System (MIS) tools and distributing them to the relevant districts. Furthermore, the project actively participated in a Seminar on "Provision of Breastfeeding Spaces at Workstations," as part of Breastfeeding Week celebrations at the DHO office in Hyderabad.

To support field operations, vehicles were procured for all Field Coordinators (FC), monitoring personnel, and management, ensuring efficient mobility. High-level meetings were held with government officials and stakeholders, including the Regional Director of Pakistan Primary Healthcare



Initiative (PPHI) in Larkana, the DDHO RMNCH in District Qambar Shahdadkot, and the District Development Manager of PPHI in Qambar Shahdadkot.

The project conducted an essential awareness session with Lady Health Supervisors (LHS) in District Central Karachi, furthering the project's reach into local communities. Furthermore, it successfully engaged with medical facilities, including MS-

Qatar Hospital Orangi Town, Children Hospital Nazimabad, RHC-Malir, and the BISP Deputy Director in District Karachi West.

A quarter concluded with staff meetings held in all districts, including a two-day orientation session for all project teams, ensuring that the project remains on track to meet its targets and deliver essential health services. These achievements collectively reflect the dedication and commitment of the BISP Kafalat Programme in its mission to reduce malnutrition and improve the overall well-being of children and families in the region.

SUPPORTING CONTRACT FOR THE IMPLEMENTATION OF THE MULTIPLE MICRONUTRIENT SUPPLEMENTATION (MMS)

Program Overview:

In pursuit of advancing the well-being of mothers and newborns, our initiative takes center stage in District Swabi. The primary focus revolves around bolstering the ongoing efforts of Nutrition International's integrated Maternal and Newborn Health and Nutrition (MNHN) interventions. To achieve this, a targeted strategy involving Multiple Micronutrient Supplementation (MMS) has been meticulously crafted and is being implemented.



The essence of our endeavor lies in providing supplemental operational support, carefully designed to



seamlessly align with Nutrition International's existing MNHN initiatives. Through MMS, we are introducing a specialized regimen that ensures mothers and newborns receive the essential array of vital micronutrients. These supplements play a pivotal role in addressing potential deficiencies and promoting optimal health during the critical maternal and newborn stages.

Our collaborative approach unites the strengths of various stakeholders, aiming to create a comprehensive ecosystem of support. By intricately weaving MMS-specific activities into the existing MNHN framework, we orchestrate a holistic tapestry of care. The ultimate goal is to enhance the health

outcomes of mothers and newborns, ushering in a brighter and healthier future for Swabi's communities.

Highlights of the Quarter:

- 1. A comprehensive plan has been developed outlining specific actions and timelines for the successful implementation of MMS in Swabi.
- 2. Hired a District Coordinator for MMS activities in Swabi in consultation with Nutrition International.
- 3. Newly hired staff has been oriented on MMS to ensure they are well-prepared for their roles.
- 4. Coordination meetings were conducted with Government Staff to ensure effective collaboration.
- 5. Program monitoring and supportive supervision have been conducted to increase the capacity of FLHW and HCP to deliver and promote MMS as part of maternal nutrition and health services in Swabi.
- 6. The District Office organized informative sessions at the District Health Office Swabi to promote Global Breastfeeding Awareness Week 2023.
- 7. A two-day training program for healthcare providers on Kangaroo Mother Care (KMC) was conducted at Bacha Khan Medical Complex.



- 8. The pre-testing of the calendar and checklist as components of the Enhanced Approaches initiative has been completed.
- 9. Provincial officials visited Swabi to monitor Maternal and Child Health Services (MMS) activities.
- 10. An introductory meeting with the District Health Officer (DHO) of Swabi was held.
- 11. A data collection process for MMS has been initiated from February 2023, which will be crucial for monitoring and assessing the impact of the program.
- 12. Regular monitoring and supervision visits have been conducted to ensure the quality and effectiveness of the MMS program.

- 13. Community leadership sessions have been organized to engage and empower local leaders in promoting the importance of MMS, creating awareness, and mobilizing community support.
- 14. The project team has actively reached out to 12 intervention Union Councils to invite community leaders to participate in the awareness and leadership sessions.

PROVISION OF CONSULTANTS & AND SPECIALIST DOCTORS TO BE PLACED IN GOVERNMENT HOSPITALS IN TEN DISTRICTS OF GILGIT-BALTISTAN

Through a Public Private Partnership, Shifa Foundation and the Gilgit-Baltistan Government are embarking on an innovative new project.

The Gilgit-Baltistan government intends to provide state-of-the-art healthcare services across Gilgit-Baltistan, with a focus on remote areas namely Hunza, Nagar, Chilas, Skardu, Ghakuch, and Aster.

Shifa Foundation is working with the Government of Gilgit-Baltistan to create a positive impact and bring about a change in the community.

The aim aim of the project is the provision of Consultants & Consultant Doctors to be placed in Government Hospitals in ten districts of Gilgit- Baltistan.



The activities carried out/completed during the reporting period includes the following:

- As part of this collaboration, Shifa Foundation and the Gilgit-Baltistan Rural Support Programme (GBRSP) have hired 60 medical specialists like Nutritionist, Nephrologist, Gynecologist, Cardiologists, Urologists, Anesthesiology, ENT, Pediatrics to date.
- The doctors have now been appointed by the government at different health centers and hospitals throughout Gilgit-Baltistan & they are performing their duties as per their specialization.

The project has also focused on raising awareness about

preventive healthcare and promoting healthy lifestyles among community members. This has been done through the distribution of informational materials, organizing health education sessions, and conducting health awareness campaigns.

• Shifa Foundation and the government of Gilgit-Baltistan have been working closely to overcome any challenges and ensure the smooth implementation of the project. Regular monitoring and evaluation have been carried out to assess the impact of the project and make any necessary adjustments.



Overall, the collaboration between Shifa Foundation and the Government of Gilgit-Baltistan has resulted in the provision of specialized medical staff, improved healthcare infrastructure, and increased access to quality healthcare services for the community members in Gilgit-Baltistan. This has brought about a positive change in the healthcare sector and has contributed to the well-being of the community.

BISP NASHONUMA PROGRAMME BALUCHISTAN

Pakistan's high rates of malnutrition (40.2% stunting, 28.9% underweight, and 17.7% wasting) are indicative of an ongoing child nutrition crisis.

The first 1,000 days of a child's life are a window of opportunity to lay a strong foundation for later achievements. This timeframe is a period of enormous change characterized by a high degree of plasticity in the child's neurological development. To address stunting prevention during the first 1000-day window of opportunity, BISP has designed a Conditional Cash Transfer intervention to increase the uptake of Health and Nutrition services of its beneficiaries. The pregnant and lactating women (PLW) and their children less than 2 years of age will be assisted through the provision of additional cash of PKR 3,000 per quarter per PLW and boy child and PKR 3,500/- per quarter per girl child of BISP beneficiary families. In return, mothers must commit to attending regular antenatal health checks and awareness sessions during pregnancy, consuming specialized nutritious food (SNF),

and taking their children for immunization and regular health checks.

Shifa Foundation is implementing **BISP Nashonuma Program** with the support of the World Food Program (WFP). The BISP Nashonuma is a health and nutrition focus program to provide Specialized Nutritious Food (SNF) and address stunting in pregnant and lactating women and children under 23 months, for the beneficiaries who are enrolled in the BISP program. The BISP Nashonuma project is being implemented in seven districts of Baluchistan including; Quetta, Killah Saifullah, Naseerabad, Sohbatpur, Jaffarabad, Sherani & Zhob

FOOD & CASH-BASED TRANSFERS FOR AN INTEGRATED CMAM

SAFETY NET PROJECT UNDER SOCIAL PROTECTION

Overview:

The Community Management of Acute Malnutrition (CMAM) project, implemented by



Shifa Foundation in Khairpur Mirs Sindh with the support of WFP, aims to provide food assistance to children and pregnant and lactating women (PBWs) suffering from malnutrition Highlights:

- During this quarter, the project made significant progress in addressing malnutrition in the community.
- A total of 115,378 children and PBWs were screened for malnutrition.
- 1,108 SAM children, 17,180 MAM children, and 60,984 normal children were identified and received assistance.
- The Targeted Supplementary Feeding Program (TSFP) and Blanket Supplementary Feeding Program (BSFP) saw 25,026 children and 26,114 PBWs enrolled.
- Substantial quantities of Acha Mum, Wawa Mum, and Mumta were distributed to meet the nutritional needs of the beneficiaries.
- Health and counseling sessions contributed to improving mother and child health.
- The project is committed to achieving long-term sustainability, including plans for cash assistance to TSFP-cured children.

Performance Analysis:

The CMAM project has made significant strides in the screening, enrollment, and distribution of food assistance in the community. Emphasis on mother and child health remains a key aspect of the project's success. However, the focus for the coming quarter is expanding the project's reach to reach more children and

PBWs suffering from malnutrition while ensuring the sustainability of interventions.

Counseling services provided during the project include:

- Counseling on breastfeeding during ANC (Antenatal Care).
- Nutrition counseling for women.
- Health-related counseling for women



VITAMIN A SUPPLEMENTATION

Project overview:

Vitamin A deficiency is a significant public health issue in Pakistan. According to the National Nutrition Survey (NNS) of 2018, 51% of children aged 6-59 months were found to be deficient in Vitamin A, with a severe deficiency rate of 12.1%. To address this concern, Shifa Foundation collaborated with Nutrition International, the Government of Pakistan, and other UN agencies to provide training for

District Focal Persons in the provinces of Punjab, Sindh, Baluchistan, Khyber Pakhtunkhwa, Gilgit Baltistan, and Azad Kashmir. Across these six training sessions, approximately 190 participants from the health department, WHO, and Health department District Focal Points took part.

Highlights:

The training sessions focused on several key aspects, including the importance of Vitamin A in



maintaining a healthy life. All training Sessions were conducted by Mr. Shahzad & and Mr. Yasin by Nutrition International with Logistic support from Shifa Foundation. In the training session, NI Team emphasized the roles of healthcare practitioners and government health department officials in achieving comprehensive coverage of Vitamin A supplementation (VAS) in their respective districts. The training comprised PowerPoint presentations, group activity, and experience sharing. In order to make the sessions more interactive and participatory, the participants were encouraged to share their feedback. During the training, participants were informed that Vitamin A deficiency could cause infections, Eyesight problems, and Night Blindness. Some important symptoms of Vitamin deficiency in

both children and adults can include dried scales on shoulders and ankles, dried eyes white spots and ulcers in the eyes, also known as "corneal ulcers." In enumerating the typical causes of Vitamin A deficiency (VAD), the NI Team pointed out the pervasiveness of insufficient/ imbalanced diet due to lack of affordability/poverty, the issue of affordability, the negligence on the part of parents may also deprive a child from getting sufficient or balanced diet, thus causing Vitamin A deficiency. Similarly, due to Zinc deficiency, Vitamin A cannot properly absorb in the body, resulting in Vitamin A deficiency. NI Team explained that VAD may also be aggravated due to changing food patterns in different seasons. Some fruits, for instance are summer fruit full of vitamin A which may not be available locally in winters. Its shortage/absence should be compensated by consuming alternate sources of Vitamin rich fruits and vegetables, such as carrots, mango and others.

This initiative aims to combat Vitamin A deficiency in Pakistan by educating and empowering individuals at various levels of the healthcare system and government to ensure the effective delivery of Vitamin A supplementations programs.

SUPPORTING FLOOD -AFFECTED POPULATION OF MITIARI

THROUGH EARLY RECOVERY CONDITIONAL CASH ASSISTANCE

Program Details:

- 1. Beneficiaries:
- Shifa Foundation is assisting a total of 5,000 households in cycles 1 and 2, with each household receiving 12,000 PKR per cycle, funded by USAID and WFP.
- Additionally, 3,000 households in cycle 3 are receiving support under the WFP conditional cash assistance program, funded by the European Union and WFP, with each household provided 25,000 PKR.
- 2. Activities:
- Structural and non-structural activities are implemented in targeted areas, and closely monitored by the M & E team of Shifa Foundation.

Highlights:

Village Prioritization and Validation of Households:

- In the third cycle, the caseload was reduced from 5,000 to 3,000 households, and these 3,000 received assistance from the European Union.
- Villages were prioritized for assistance, and household validation was closely monitored by WFP and Shifa Foundation.

Training Programs:

- Training programs in collaboration with WFP and the European Union aimed to enhance participants' skills, particularly in improving their livelihoods during unforeseen disasters.
- Shifa Foundation worked closely with Village Development Committees to identify ways to enhance livelihoods and organized various training sessions.

Infrastructure Development:

- Construction activities were carried out in response to flood situations, including the installation of concrete pipes for water flow and the construction of culverts on irrigation lands.
- Mud houses with wooden rooftops were built for families whose homes were completely destroyed, thanks to funding from the World Food Program.

WFP 3000-Caseload Cycle-4 Early Recovery Program:

- A comprehensive household assessment was conducted for the 3,000 caseloads for Cycle 4 of the early recovery program, funded by New Zealand.
- Prioritization was done in collaboration with district administration, Union Councils, and various stakeholders.

National and Global Celebrations:



- District-wide celebrations for World Breastfeeding Week and Independence Day were organized in collaboration with the District Health Office and Shifa Foundation teams.

In conclusion, the WFP Early Recovery Conditional Cash Assistance Activity & Livelihood Program

CBT project, implemented by Shifa Foundation in Mitiari, has achieved remarkable progress in providing assistance to the floodaffected population. The project has successfully disbursed cash assistance to individuals and households, enhancing their resilience and supporting their recovery. These efforts are crucial in addressing the challenges posed by flooding in the region promoting improved and



livelihoods for the affected population.

REDUCING CORPORAL PUNISHMENT IN SCHOOLS

After successful completion of feasibility study in three regions namely Sindh, Islamabad and AJK now we are scaling up the project to 48 schools where1,296 students and 720 teachers across 4 study sites in Pakistan (12 schools at each study site: Khyber Pakhtunkhwa province, Sindh province, the State of Azad Jammu & Kashmir, and the federal capital Islamabad + Punjab province) will be interviewed while teachers of the 24 schools will be trained under the Cluster Randomized Control Trial model. At the end of the project



Shifa Foundation will complete trainings of 360 teachers and assess 720 teachers and 1300 students.

- Meeting with C.E.O District education Authority Rawalpindi, meeting was about orientation of ICC-T project CRCT phase.

- Conducted 5 days ICC-T training with AJ&K, Islamabad + Punjab and Sindh Master Trainer Team.
- Re-requested for NOC along with the list of randomly selected schools to Secretary Education and Director, directorate of education extension Muzaffarabad.
- Two days detailed Training session with Florian and Kate about Training of Research assistant
- Meeting with Dr. Tabasum Deputy Director and Dr. Rifat Director, along with Said Shah Sahib, our Program Manager, we discussed the findings of the ICC-T feasibility study and emphasized its importance for our teachers, students, and the community. We also requested to put-up the file of 8 randomly selected schools in Islamabad.

SHIFA FOUNDATION AFGHANISTAN: OVERVIEW AND PROGRES

During the 1st quarter (July to September 2023), Shifa Foundation Afghanistan achieved significant milestones and reinforced vital partnerships. The period commenced with active participation in UNICEF's Nutrition Cluster Coordination Meeting, highlighting the organization's commitment to collaborative efforts in addressing nutrition challenges.

A crucial achievement was the signing of a Memorandum of Understanding (MOU) with the Afghanistan National Re-construction Coordination (ANCC), which paves the way for joint initiatives in reconstruction and development. Shifa Foundation secured cluster registration for Afghanistan's Emergency Shelter and Non-Food Items (NFI) Cluster, enhancing its capacity for effective emergency response.

To streamline operations, Shifa Foundation initiated bank account opening discussions with Bank Alfalah Ltd. Additionally, high-level meetings with government officials and Ummah Welfare Trust (UWT) explored collaborations for community well-being and humanitarian efforts.

Further engagements included productive discussions on medical equipment and medicines with UWT and data collection efforts. Shifa Foundation Afghanistan demonstrated its commitment to financial compliance through tax clearance initiation for 2022-2023.

These achievements highlights Shifa Foundation Afghanistan's dedication to holistic well-being, community development, and partnerships that contribute to a brighter future.

- UNICEF Nutrition Cluster Coordination Meeting: The month kicked off with Shifa Foundation
 Afghanistan's participation in the Regular UNICEF Monthly Nutrition Cluster Coordination
 Online Meeting. This engagement underscored Shifa Foundation's dedication to fostering a
 collaborative approach towards addressing nutrition challenges within the region, ensuring a
 coordinated response for improved outcomes.
- 2. MOU Signing with Afghanistan National Re-construction Coordination (ANCC):

Demonstrating its commitment to effective cooperation, Shifa Foundation Afghanistan marked a significant milestone by signing a Memorandum of Understanding (MOU) with the Afghanistan National Re-construction Coordination (ANCC). This strategic partnership sets the stage for synergistic efforts in reconstruction and development initiatives, amplifying Shifa Foundation's impact within the community.



- 3. Cluster Registration for Emergency Shelter and NFI Cluster: Shifa Foundation's dedication to holistic well-being was further evident as it secured cluster registration for Afghanistan's Emergency Shelter and Non-Food Items (NFI) Cluster. This accomplishment solidifies SF's role in providing vital support during emergencies, enhancing disaster response capabilities for the benefit of vulnerable populations.
- 4. **Engagement with Bank Alfalah Ltd for Bank Account Opening:** In its pursuit of operational efficiency, Shifa Foundation Afghanistan proactively engaged in follow-up meetings with Bank Alfalah Ltd to initiate the process of opening a dedicated bank account. This step underscores the SF commitment to financial transparency and streamlined operations.
- Collaborative 5. **High-Level** Meetings: Shifa Foundation engaged in two pivotal high-level meetings, signifying its commitment to forging meaningful collaborations. In the first meeting with Mr. Muhammad Azim Kakar and Mr. Khyber Rafi, Advisors to the Ministry of Public Health (MoPH), discussions revolved around collaborative effort between Ummah Welfare Trust (UWT) and Shifa Foundation Afghanistan, reinforcing Shifa Foundation's commitment to broader community well-being.



The second meeting with His Excellency Shiakh-Ul-Hadith Mawlawi Nida Muhammad Nadeem, Minister, and Dr. Lutfullah Khirkhwah of the Ministry of Higher Education (MOHE),



explored potential collaboration between UWT and Shifa Foundation Afghanistan, aligning humanitarian efforts for a more holistic impact. Through these achievements and engagements, Shifa Foundation Afghanistan's impact reverberates beyond the calendar month, serving as a testament to its dedication to holistic well-being, community development, and partnerships that pave the way for a brighter future.

Meeting with Ministry of Public Health

A meeting was held with key officials at the Ministry of Public Health (MOPH) on August 7, 2023. Deputy Minister Mowlawie Muhammad Ishaq Asim, Advisor to the Minister Mr. Muhammad Azim Kakar, and Mr. Khyber Rafi, Advisor to the Deputy Minister, were present. The discussion revolved around the equipment list submitted to Shifa Foundation Afghanistan. Deputy Minister Mowlawie Muhammad Ishaq Asim granted permission to visit three hospitals constructed by the Government of the Islamic Republic of Pakistan and Noor Eye Hospital. Shifa Foundation staff were introduced to a health director to facilitate their visits to these hospitals, including Muhammad Ali Jinnah Hospitals and Noor Eye Hospital within Kabul, and Niab Aminullah Logari Hospital in Logar Province.

Visit to Muhammad Ali Jinnah Hospital

Muhammad Ali Jinnah Hospital, located in the western part of District Six of Kabul City, was visited. The hospital, spanning 24 Jeribs, had its construction and equipment supply funded by the

Government of Pakistan. Construction commenced in 2008, completed in 2012, and the equipment supply occurred between 2018 and 2019. It houses 200 beds and became operational a few months ago with limited resources.



Visit of Noor Hospital (Noor Chesham Hospital)

A visit to Noor Hospital was conducted on August 7, 2023. The

hospital, situated in the heart of Kabul City, receives support from normal government funding. According to HMIS reports, it serves approximately 100,000 patients annually in the Outpatient Department (OPD), with 6,500 admissions per year, including major and minor surgeries. The hospital currently has 86 active beds.

Visit to Niab Aminullah Logari Hospital

Niab Aminullah Logari Hospital, visited on August 9, 2023, is located 50 kilometers south of Kabul on the Kabul-Logar highway, in the remote area of Logar Province. This hospital, covering 21 Jeribs, had its construction and equipment funded by the Government of Pakistan. Construction started in 2008, was completed in 2012 by NESPAK, and received equipment in 2019. The hospital boasts 158 beds and has been operational for about a year, providing services similar to Muhammad Ali Jinnah Hospital, including daily OPDs for medical, general surgery, gynecology, and vaccinations. Orthopedic and general surgeries are also conducted, and there are no OPD and surgery fees.

Meeting at the Ministry of Public Health (13-Aug-2023)

On August 13, 2023, another meeting was held with Deputy Minister Mowlawie Muhammad Ishaq Asim, Advisor Mr. Muhammad Azim Kakar, and Advisor Mr. Khyber Rafi at the Ministry of Public Health. The objective was to request the reflection of data in the format sent by UWT, which the MOPH agreed to share. During the month of August 2023, Shifa Foundation conducted multiple follow-up visits, resulting in the receipt of 90% of the required data.



Nishtar Kidney Hospital Visit (14-Aug-2023):

Shifa Foundation conducted a visit to Nishter Kidney Hospital in Jalalabad, Nangarhar Province, on August 14, 2023, with permission from the Ministry of Public Health (MOPH). This hospital, located in Jalalabad City, the capital of Nangarhar Province, Eastern Region of Afghanistan, is situated approximately 160 kilometers from Kabul. Covering an extensive area of 28 Jeribs, the



hospital primarily focuses on Nephrology and Urology services and houses 65 beds. Funding for both construction and equipment supply was provided by the Government of the Islamic Republic of Pakistan. The hospital handles an approximate daily count of 130 patients in the Outpatient Department (OPD) for Nephrology and Urology, with 8 Inpatient Department (IPD) patients per day.

Ministry of Higher Education Meeting with Academic Coordinator (13-Aug-2023):

A meeting was convened with the Academic Coordinator of the Ministry of Higher Education (MOHE) on August 13, 2023. The meeting's agenda included sharing the required format with MOHE and requesting data to be presented in the format provided by UWT. The MOHE Academic Coordinator consented to visit teaching hospitals within Kabul to facilitate data collection. Subsequently, visits were conducted to various teaching hospitals, including Ali Abad Teaching Hospital on 16-August-2023, Stomatology Teaching Hospital on 17-August-2023, Cardiothoracic Teaching Hospital on 20-August-2023, Eye Teaching Hospital on 21-August-2023, and Maiwand Teaching Hospital and Sharara Gyn Teaching Hospital on 23-August-2023. Several follow-up visits by MOHE and respective teaching hospitals were carried out to ensure efficient data collection.

Meeting with Ministry of Higher Education (MOHE) and Country Manager Operations

A follow-up meeting was held between H.E Dr. Lutfullah Khair khawah, the Academic Deputy Minister of the Ministry of Higher Education, and Ihsan Ullah, the Country Manager Operations of Shifa Foundation Afghanistan on September 12, 2023, at MOHE. Dr. Zabih-Ullah, the Academic Coordinator, also participated in the meeting. During this meeting, several key points were discussed:

- 1. **Equipment List Preparation:** The Deputy Minister instructed the Coordinator to expedite the preparation of a list of new equipment for teaching hospitals. The list should adhere to the specified format and specifications to prevent any further delays.
- 2. **Repair and Installation:** The Deputy Minister emphasized the importance of repairing and installing existing equipment in teaching hospitals. Ensuring the proper functioning of the equipment is crucial for the effective operation of these medical facilities.

Tax Clearance Initiated

Shifa Foundation Afghanistan initiated the tax clearance process for the year 2022-2023, commencing in September 2023 and concluding on March 21, 2023. This demonstrates our commitment to fulfilling all necessary financial obligations.

Meeting with UWT (United World Trust) Country Representative

On September 27, 2023, a meeting was conducted with Mr. Afaq Khan, the Country Representative of UWT, at the UWT office in Kabul. The meeting commenced with introductions and covered the following significant topics:

- 1. **Medical Equipment and Medicines:** A detailed discussion took place regarding the medical equipment and medicines requested by the Ministry of Public Health (MOPH) and MOHE. Ensuring the availability of necessary medical supplies is essential for supporting healthcare services in Afghanistan.
- 2. **Data Collection for Hospitals:** The meeting also included discussions on data collection for hospitals. Accurate and up-to-date data is critical for informed decision-making and resource allocation.
- Cheshm-i-Noor Hospital Proposal: The proposal for Cheshm-i-Noor Hospital was discussed, indicating Shifa Foundation's commitment to expanding healthcare services to benefit a broader population.

CENTRE OF PHILANTHROPY AND COMMUNITY SERVICES (COPCS)

1. SUMMARY

This report will highlight the progress and achievement of the COPCS department during the 1st quarter (July, August, and September) of 2023, COPCS department aims to provide support and uplift underprivileged communities by involving potential donors, philanthropists, and volunteers. One of the main functions of the COPCS department is to raise funds from local and international donor organizations, companies, and philanthropists, through indigenous fundraising with the support of volunteers. During the last three months, the COPCS department has collected donations of **Rs. 4,080,342/-** through different sources.

During the reporting quarter, the COPCS department performed multiple tasks. The COPCS team reached out to 918989 people through its website and different social media platforms. similarly, through Feed the Poor initiatives, COPCs distributed food packages among 242 families in different underprivileged communities. Moreover, Shifa Foundation has also provided free treatment to 66 deserving individuals through a patient treatment panel in Shifa International Hospital.

2. COMMUNITY SERVICES

2.1. HEALTHCARE

Shifa Foundation plays a vital role in providing health care services to underprivileged communities through patient treatment panels. Shifa Foundation facilitates deserving patients through restricted accounts and general donations in Shifa Falahi Clinic and Shifa International Hospital. During the second quarter of the fiscal year, 66 patients were diagnosed with different diseases and facilitated through the patient treatment panel. The detail of the patients facilitated during this quarter is mentioned below in table 2.1.1.





FEED THE POOR



The Feed the Poor program is one of the most important initiatives of Shifa Foundation that aims to reduce the vulnerabilities of underprivileged families in Pakistan by providing food packages to meet their monthly dietary needs. Shifa Foundation strives to generate regular donations from its donors to distribute food packages among the identified poor families on monthly basis.

During the first quarter (July, August, and September) Shifa

Foundation distributed food packages among 140 households in different areas including Islamabad, Rawalpindi, Jhelum, and Daman.

A total of 3.2 metric tons of food was distributed which benefited 980 individuals. Shifa foundation aims to reach out to more families who are in dire need of support with the help of our generous donors.

2.2. BREAST CANCER AWARENESS CAMPAIGN

The Pink Lady Breast Cancer Awareness Campaign was launched by Shifa Foundation in 2019 in order to educate the masses about the importance of prevention, early detection, and timely treatment of Breast Cancer. Pink Lady Awareness Campaign highlights the miseries of those who, at any stage of life, have battled against Breast Cancer. Shifa Foundation strongly believes and advocates that early detection can save thousands of precious lives.



Shifa Foundation believes that



early detection of breast cancer can save thousands of precious lives. Pink Lady Breast Cancer Awareness Campaign is celebrated each year in October to educate the masses about the importance of prevention, early detection, and timely treatment of Breast Cancer. During the Pink Lady Awareness Campaign, Shifa Foundation conducts a large number of cancer awareness sessions in

educational institutions and the corporate sector alongside raising awareness in the public through social and conventional media.

Shifa Foundation sensitizes and engages various stakeholders in the Pink Lady Campaign to encourage multi-lateral collaboration and joint efforts for prevention as well as to reduce the annual ratio of deaths caused by Breast Cancer.

Shifa Foundation also aims to provide Breast Cancer Self Detection services in hospitals, women's universities, and girl's colleges to ensure early





detection of Breast Cancer and to establish a referral mechanism for the treatment of underprivileged females.



3. PARTNERSHIP DEVELOPMENT

Shifa Foundation gives key importance to maintaining and enhancing coordination with its stakeholders. During the reporting months, Shifa Foundation engaged multiple education institutions, and corporate companies for future collaboration. The meeting was attended by the management of both organizations. It was decided during the meeting that an MOU will be signed between WWF and Shifa Foundation in the near future and both organizations will work together for better delivery of services. Another major work of the COPCS department is to coordinate with different Consultants inside Shifa International Hospital to take them on onboard in the facilitation of deserving patients. During the second quarter, an MOU was signed with Cardiology associates to assist deserving patients through Shifa Foundation I-9 Panel in a better way. Several MOUs were renewed as well.

Apart from Corporate sectors, Shifa Foundation maintains its relationship with individual donors as well. During the reporting quarter, the COPCS department sent a sensitization email to previous donors to acknowledge their generous contributions and encourage future contributions.

4. Two-Day Health Expo Organized by RCCI:

The RCCI successfully arranged a two-day Health Expo on 16-17 August 2023 that brought together a diverse array of participants including pharmaceutical companies, hospitals, Universities, software houses working on AI for diagnosis, and corporate organizations.

The event provided a unique platform for organizations dedicated to healthcare and well-being, including Shifa Foundation, to present our mission and initiatives to a diverse audience. This expo was a remarkable opportunity to showcase our commitment to bettering the health of our community and beyond.

Shifa Foundation has utilized the platform to its best and presented the Shifa Foundation's services to the underprivileged communities, and sensitized the general public and the VIPs including the President Republic of Pakistan Dr. Arif Alvi, Ambassadors, High commissions, Union Delegations, and President of JCCI while their visit to Shifa Foundation stall. RCCI presented an award for participation in the Health Expo.

5. Breast Feeding Month:

Breastfeeding is a journey that builds strong bonds between mothers and their babies while laying the foundation for a healthier future.

Shifa Foundation has organized awareness sessions in the corporate and educational sectors for the whole month of August. The purpose of the activity was to create awareness among the general public through active participation and as well as media coverage of the activity. The workshop consisted of an hour-long session / talk on the importance of breastfeeding, its benefits and risks, etc.

Objectives:

- To raise awareness about the importance of breastfeeding among the general public.
- To raise funds through sponsorships/individuals for the underprivileged/deserving mothers and children by providing them with nutrients.








Subfertility Awareness & **IUI Workshop**





Day 2:


September 12, 2023: On the second day, all participants gathered at the E-4 Conference Room.

The presentation covered the historical context of contraception and its role in pre-pregnancy care.

She drew a clear distinction between IUGR and Small for Gestational Age (SGA), underlining that the former denotes a restriction in genetic growth potential, while the latter relies on percentile measures.

The talk also brought to light startling statistics, highlighting IUGR's substantial contribution to perinatal mortality and its alarming link to intrapartum asphyxia. Delving deeper into the subject, Dr. Rehana dissected the multitude of factors contributing to IUGR, spanning maternal, fetal, and placental causes, fostering a holistic comprehension of its intricate etiology. Furthermore, she offered invaluable guidance on risk assessment and antenatal surveillance, underscoring the significance of early detection and appropriate management to mitigate perinatal risks. By emphasizing the pivotal role of Doppler studies, biophysical profiles, and other surveillance modalities, the talk armed healthcare professionals with

essential tools to effectively monitor and address IUGR cases, ultimately championing better outcomes for both expecting mothers and their infants.

We also explored circulation changes, thermoregulation, and practical steps to minimize heat loss. This knowledge will undoubtedly enhance neonatal care and reduce preventable newborn deaths.

The presentation underscored the critical importance of neonatal resuscitation, especially in regions like Pakistan, where the neonatal mortality rate remains a significant concern. It was noted that the neonatal mortality rate in Pakistan has gradually decreased over the years, but it still contributes substantially to child mortality. The statistics emphasize the urgency of improving neonatal care practices. The insights gained from this presentation will not only empower healthcare professionals

to save more lives but also drive efforts to further reduce neonatal mortality rates globally.

Additionally, the presentation stressed the significance of listening to patients, understanding their values, and providing information about the benefits and risks of proposed options.

A key takeaway was the presumption that adult patients possess the capacity to make decisions about their treatment and care unless otherwise assessed according to legal requirements. For patients lacking capacity, decisions should be made in their overall best interest and in consultation with those close to them or advocating for them. Furthermore, the presentation covered scenarios for consent, including various medical procedures such as

hysterectomy, blood tests, genetic testing, and more.

In conclusion, the presentation on consent-taking reinforced the importance of respecting patients' autonomy, ensuring informed decision-making, and following ethical guidelines in healthcare. It provided valuable insights and practical guidance for healthcare professionals to uphold patients' rights and ethical obligations.

In the case of major or massive antepartum hemorrhage, rapid administration of blood and blood products was highlighted to stabilize the patient. Neonatal care considerations, prophylactic steroids, and anti-D immunoglobulin were also discussed to optimize outcomes. The presentation seamlessly transitioned to the management of postpartum hemorrhage, utilizing the "4 Ts" approach (Tone, Trauma, Tissue, Thrombus) to identify underlying causes and underscored the importance of prompt recognition and intervention.

In conclusion, the presentation provided comprehensive framework providers healthcare to manage antepartum and postpartum hemorrhage effectively. By prioritizing early recognition, timely referral, and a systematic approach, it aimed to ensure the safety of both mothers and babies during the critical stages of pregnancy and childbirth.

The statistics presented painted a concerning picture of the prevalence of these infections in both high-income and low- to middle-income countries. Understanding the risks associated with nosocomial infections is vital for healthcare professionals to ensure the safety and well-being of patients.

Ms. Arifa's presentation didn't merely highlight the challenges but also offered solutions. She emphasized the importance of Standard Precautions, which are fundamental infection prevention practices applicable to all patients. Hand hygiene,

services. This hub is complemented by satellite campuses or spokes, which extend healthcare services to a broader market but with a more limited range of services. The benefits of this model include uniformity, improved quality of care, increased efficiency, and broader market coverage. However, challenges like congestion at the hub, limited feasibility of patient movement between sites, and potential staff dissatisfaction need to be addressed.



The session delved into the design of services, clinical governance, clinical policies, information flow, patient safety, and various operational aspects of the hub and spoke model. It highlighted the importance of synchronized patient data transmission and efficient referral systems to ensure seamless healthcare delivery. Dr. Farah Naz Ansari's presentation on the hub and spoke model in healthcare during the session was not only informative but also offered practical insights into its implementation. Attendees left the session with a deeper understanding of how this model can revolutionize healthcare delivery, particularly in reaching underserved areas and optimizing resource allocation. Dr. Farah's expertise and guidance were instrumental in shedding light on the intricacies of designing, implementing, and managing such a system. This session served as a catalyst for healthcare professionals to explore innovative ways of improving healthcare access and quality, ultimately benefiting both patients and providers.

Overall, this event provided a comprehensive overview of the hub and spoke model in healthcare, equipping attendees with the knowledge and tools to implement this approach effectively in their healthcare organizations



Day 9:

On the ninth day of the session, which took place on September 20, 2023, all attendees gathered in the Quality Conference Room. It was at this moment that Dr. Manahil Majeed commenced her presentation, addressing the vital topic of "Early Pregnancy Disorders: Cord Prolapse."

Presenter: Dr. Manahil Majeed

Facilitator: Dr. Shazia Fakhar

Topic: Early Pregnancy Disorders: Cord Prolapse

During the session led by Dr. Manahil Majeed, attendees gained valuable insights into early pregnancy disorders, with a focus on Gestational Trophoblastic Disease (GTD). Dr. Majeed began by defining GTD as a diverse group of conditions originating from the trophoblastic epithelium of the placenta, characterized by elevated Bhcg levels, which distinguish them from maternal tissue. The session highlighted the rarity of GTD, with an incidence of 1 in 50,000 after live births and 1 in 20,000 after pregnancy termination. Additionally, Dr. Majeed discussed the recurrence rate, which stands at 1 in 80 after one molar pregnancy.

The session delved into the classification of GTD, distinguishing between complete moles and partial moles. Complete moles are diploid and androgenic in origin and lack fetal tissue, while partial moles are 90% triploid and 10% tetraploid, showing evidence of a fetus and fetal red blood cells. Dr. Majeed also covered the presenting symptoms of GTD, such as vaginal bleeding, hyperemesis, and uterine enlargement, emphasizing the importance of early diagnosis.

Moreover, the presentation touched upon ectopic pregnancies, which occur when a pregnancy implants outside the uterus. Attendees learned about the incidence, risk factors, common symptoms



like abdominal or pelvic pain and vaginal bleeding, and diagnostic methods, with a strong emphasis on transvaginal scans. The session also provided insights into the management of ectopic pregnancies, offering expectant, medical, and surgical options based on clinical stability.

Lastly, Dr. Majeed addressed miscarriages, defining them as pregnancy losses before viability, up to 24 weeks of gestation. The audience was informed about the incidence, risk factors, and various types of miscarriages. The session covered the initial

assessment, history and examination, and the importance of investigating recurrent miscarriages. Attendees gained knowledge about the diverse factors contributing to miscarriages, from genetic and embryonic factors to anatomical and endocrine factors. Dr. Majeed concluded the session by discussing different management approaches, including expectant, medical, and surgical options, depending on the patient's condition and preferences.

Presenter: Dr. Farah Naz Ansari

Topic: Innovation in Health care and Hub & Spoke Model

Dr. Farah Naz Ansari, delivered an engaging session on innovation in healthcare and the Hub & Spoke Model. She challenged attendees to envision innovations that could enhance daily medical practice, encouraging a forward-thinking approach in the face of obstacles. Dr. Farah emphasized the importance of embracing change and adapting to the evolving landscape of healthcare.



In her presentation, Dr. Farah defined innovation as the combination of invention, adoption, and diffusion. She highlighted three main types of innovations in healthcare: novel ideas, new products, and innovative service or care pathways. Drawing inspiration from the Chinese proverb, "When winds of change blow, some build walls and others build windmills," she underscored the need to harness change as an opportunity for growth.





The ingredients of successful innovation were outlined as being useful, doable, budget/profitable, scalable, measurable, and time-bound. Dr. Farah referred to the World Economic Forum's list of healthcare innovations, including artificial intelligence, 3D printing, CRISPR gene editing, virtual reality, and smart bandages. She encouraged attendees to think about areas of innovation

within healthcare, such as supervision systems, referral systems, drug supply and management, infection control, patient safety, governance, medical records, and quality/service improvement.

Overall, Dr. Farah's session inspired healthcare professionals to embrace innovation as a means of enhancing patient care and advancing the field of medicine. Her thought-provoking presentation left attendees with valuable insights and ideas to explore in their daily practices.



Day 10:

On the day of the closing ceremony, all participants were administered a post-test to assess their understanding and knowledge gained during the 10-day training program. The attendance process was meticulously documented to ensure accurate records of the participants' engagement. Dr. Farah Naz Ansari, delivered her closing remarks, summarizing the key takeaways from the training and emphasizing the importance of continued learning and innovation in healthcare.

Following Dr. Farah's remarks, Mr. Usman Ahmed, Dr. Zafar, and Dr. Masuma Zaidi also shared their closing remarks, offering insights and perspectives on the training program's impact and the broader healthcare landscape.

Several participants had the opportunity to share their feedback on the 10-day training, highlighting their experiences, key learnings, and the value they gained from the program. As a token of appreciation, certificates were distributed to all the faculty members and participants in recognition of their dedication and active participation. Additionally, participants received a USB drive as a souvenir, containing all the educational materials and data covered during the training.
